DISCUSSION	<ul style="list-style-type: none"> 523 current enrollment 502 for next year assuming everyone rolls over, new GATE and Ex Ed kids. We currently have 33 kinder registered for next year. Our rule of thumb has been to double whatever the number is the first week of May. State Testing season, ORF for 3rd grade already and AZ Sci for 5th grade. Writing is coming up 3-5th. Reading and math April 13th and 14th. Next two months a lot going on, performances, teacher planning days, Title 1 funds for summer work for staff. Limited summer school/work opportunities. We are not hosting this year. We will invite students in the lower 25%. Cub Club will be throughout the summer on campus. Summer PD will be slim this year through TUSD.

The amount of field trips classes take are not equal and the amount of money collected by teachers is very different. DISCUSSION NOTES	<ul style="list-style-type: none"> • We will have \$9,000.00 less next year. Title 1 currently pays for the dean of students, a reading interventionist, a behavior interventionist and a part-time TA. Next year the dean of students will be a .5 position and TA hours can be increased. • We filled five position at the recent hiring fair. In 2025-26 there will be three Kinder teachers, including new hire Annabelle Mirales. There will be four 1st, 2nd, and 3rd grade classes with new hires Taylor Perkins & Elizabeth McCormick Rodriguez joining 3rd grade. There are four 4th grade classes with 4th Ms. Metzler looping, and new hire Kimberly Salazar in 4th grade GATE. Ms. Lauderdale will teach a 4th-5th GATE combo. There will be four 5th grade classes, with new hire Dariana Salazar joining our team. • Final numbers for Ex Ed TA's are not determined yet. The self-contained class will continue. Our Ex. Ed Resource teachers will be Ms. Huber at .8, Ms. Lopez is full time and Ms. Nuguid at .2. • OMA- full time AIS, .4 Visual Arts, new staff Trista Tamura. • PE Mr. Legan • TA hours to be discussed at the next meeting. • All other positions stay the same. • MTSS, CSP & RTI math interventionists were ESSER funded and now are district central funded.
